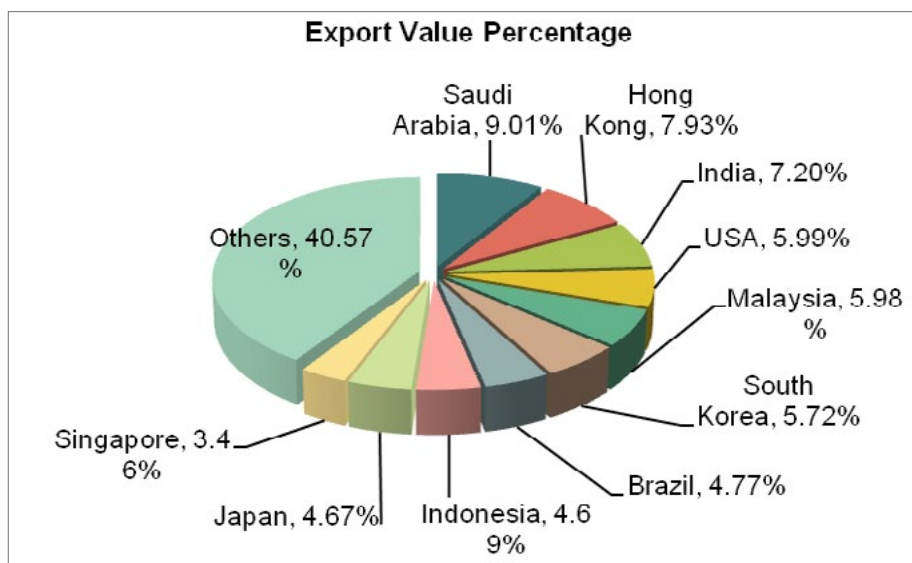

As seen from the export data of Jan.-August in 2013, our country's motor vehicle for short distance transportation main exporting source areas are Jiangsu, Shandong and Zhejiang, among of which, the export value of Jiangsu accounted for 35.70% of the total export value of China.

Our country's motor vehicle for short distance transportation export value amounted to about 34 million US dollars from Jan. to August in 2013, with an increase of 42.4% year on year. Main export countries/regions are Saudi Arabia, Hong Kong, India, the United States, Malaysia, South Korea, Brazil, Indonesia, Japan and Singapore and so on. Saudi Arabia is China motor vehicle for short distance transportation's key export market. The export value to Saudi Arabia accounted about 9.01% of the total export value of the product. From Jan. to August in 2013, among the top ten export markets, the export value to the United States and South Korea declined, while the export value to the other eight export markets all increased more than 100%.

The United States is the world's biggest demanding country of motor vehicle for short distance transportation from Jan. to June in 2013. The import value is 334 million US dollars, which is 8.5 times of the import value of the second ranked South Korea.

The export value of the United States, which is the world's main export country of motor vehicle for short distance transportation, amounted to 190 million US dollars from Jan. to June in 2013. Germany ranked the second, and the export value of the first half year of 2013 is 36% of that of the United States.
