


From Jan. to June in 2013, among the top ten export destination countries/regions, the export volume of Iran increased the largest (with an increase of 99.3% year on year), while the export value of Iran also increased the largest (with an increase of 99.2% year on year), followed by India (with an increase of 45.8% year on year).

## **3. Global Scissors and Similar Articles (HS: 8213) Import and Export Analysis**

3.1. Global Import Value Trend of Scissors and Similar Articles (HS: 8213) from 2010 to 2012



The total import value of global scissors and similar articles increased year by year from 2010 to 2012, and the import value of 2012 amounted to 627 million US dollars, with an increase of 8.97% year on year.

China's competitive advantage is more obvious.

China is the United States' largest import source country of scissors and similar articles, accounted for 68.67% of the total import value, followed by Taiwan Area, accounting for 11.52% of the total import value.

It is noteworthy that the United States' import value of scissors and similar articles from Finland amounted to 270,000 US dollars in the first quarter of 2013, with an increase of 210.34% year on year, which is a significant increase.

China is the Germany's largest import source country of scissors and similar articles, accounted for 43.76% of the total import value, followed by Pakistan, accounting for 10.03% of the total import value.

It is noteworthy that the Germany's import value of scissors and similar articles from Turkey amounted to 200,000 US dollars in the first quarter of 2013, with an increase of 506.06% year on year, which is a significant increase.
