



• 2013 Furniture Industry Export Structure(By Export Value)


2013, China Seats & Accessory export value approached \$ 229.57 million USD, and increased 5.3% compared the same period last year. Account for 38.2% of total furniture export value; Medical and Beauty salon furniture export value reached 5.98 million USD, and increased 11.8% compared the same period last year, account for 0.99% of total furniture export value; Spring mattress, bedding and similar products export value reached 76.69 million USD, and increased 4% compared the same period last year, account for 12.76% of total furniture export value; Other furniture and accessory export value approached \$ 288.73 million USD, and increased 6.8% compared the same period last year. Account for 48.04% of total furniture export value;



In 2013 China furniture mainly exported to USA ,Japan, United Kingdom, Malaysia, Australia, Germany, Hong Kong, Canada, the United Arab Emirates and Singapore and other countries / regions, exports to these 10 countries / regions amounted to 62.93% of total China furniture export quantity. The USA is China's most important furniture export market, in 2013 China's export to USA furniture accounted for 28.66% of the Chinese furniture total export. In the TOP 20 export of China's furniture market in 2013, China for Hong Kong's furniture exports year-on-year growth of 90.98%, which is the fastest growth.




1.2.1. 2013 China Seats & Accessory Major Export Country & Region Distribution

In 2013, Chinese seats and parts are mainly exported to USA, Japan, United Kingdom ,Germany, Australia, Canada, Malaysia, South Korea, Holland and France and other countries / regions, seats and parts exports to this 10 markets accounted for 64.18% of total exports. The America is the main export markets (seats & parts) for China. In 2013 China 30.51% seats and parts exported to the USA.




1.2.2. 2013 China Medical Furniture & Beauty Salon Major Export Country & Region Distribution

1.2.3. 2013 China Other Furniture and Parts Major Export Country and Region Distribution










1.3.1. 2013 China Seats & Accessory Export Original Places Distribution






1.3.3. 2013 China Other Furniture and Part Major Export Original Places Distribution

1.3.4. 2013 China Spring Mattress, Bedding and Similar Products Mainly Export Original Place Distribution.








