





1.1. 2011-2013 Chinese Electric Wire and Cable Export Volume Trend



From 2011 to 2013, the export volume of Chinese electric wire and cable increased year by year. In 2013, the export volume amounted to 2.0548 million tons, which increased 6.1% compared to the same period of 2012.





1.2. 2011-2013 Chinese Electric Wire and Cable Export Value Trend

From 2011 to 2013, the export value of Chinese electric wire and cable increased year by year, as same as the export volume trend shown in the above chart. In 2013, the export value amounted to 19.439 billion dollars, which increased 11.6% compared to the same period of 2012.

The first three largest export markets were Hong Kong, USA and Japan from 2011 to 2013. Japan, which used to rank the fourth place in 2012, was the second largest export market in 2013, surmounted United Kingdom and Saudi Arabia. Among the above twenty export markets in 2013, the export value to Malaysia showed the largest increase of 106.37%, compared to 2011. The export value to India, Canada and Taiwan declined 25.07%, 8.14% and 26.43% respectively, compared to 2011.



As can be seen from the export statistics from Jan. to Jun. in 2014, the major export markets for Chinese electric wire and cable were Hong Kong, USA, Japan, Republic of Korea, Singapore, Australia, Germany, Thailand, Indonesia and India, etc.

The first three largest export markets for Chinese electric wire and cable were Hong Kong, USA and Japan, whose export value accounted for 21.82%, 15.14% and 12.12% of the total export value respectively.



USA was the largest import country for global electric wire and cable. The import value of 2013 was about 17.313 billion dollars, increased 18.19% compared to the same period of 2011. Germany and Japan ranked the second and third place, whose import value was 9.591 billion dollars and 6.437 billion dollars respectively. Among the top twenty export import countries and regions in 2013, Hong Kong increased the largest, with 67.53% increase compared to the same period of 2011.



Mexico and China were the top two import sources of electric wire and cable for USA. In 2013, USA imported 3.8 billion dollars of electric wire and cable from China, which accounted for 21.94% of the total import value of these products. Among the top twenty import markets for USA, the import value from Turkey increased greatly, with 143.69% increase, compared to 2011.



From 2011 to 2013, China, Viet Nam and Philippines were the top three import sources of electric wire and cable for Japan. In 2013, Japan imported 2.762 billion dollars of electric wire and cable from China, which accounted for 42.91% of the total import value of these products. Among the top twenty import markets for Japan in 2013, the import value from Italy and Slovakia increased greatly, with 186.25% and 906.64% increase respectively, compared to 2011.








